## Sustainable Transportation Options from the Airport to the Venue

Copenhagen offers various sustainable transportation options, from the airport to the Bella Center. Here are some eco-friendly ways to travel:

- **Metro:** The most convenient and eco-friendly way is to take the Metro directly from Copenhagen Airport to Bella Center. The Metro runs frequently, is efficient, and has a minimal environmental impact. The Bella Center has its own station, named "Bella Center Station," making it a convenient choice.

- **Public Bus:** Public buses are also available from the airport to Bella Center. While not as direct as the Metro, they are a viable option. Look for buses that stop close to the Bella Center or connect to nearby Metro stations.

- **Electric Taxis or Car-Sharing Services:** Look for electric or hybrid taxis or opt for car-sharing services that prioritise eco-friendly vehicles. Several companies provide electric cars for rent by the minute within the city.
